PYRAMID LAKE FISHING GUIDE PERMIT AND BOAT CHARTER
APPLICATION

Attention: The following will apply without exception.

1. All applicable sections of the fishing guide permit and boat charter application must be complete and legible prior to validation. No “pending”, “unknown” or blanks will be accepted.
2. Incomplete permit applications will be returned resulting in a processing delay.
3. A signature is required.
4. A fishing guide and boat charter permit will be mailed within seven days of application approval.
5. All guide permits will be valid for the fishing season running October 1 through September 30 of the year for which permitted.
6. Fee for both fishing guide permits and boat charters is \$1,600 each per year.
7. Tribal member fishing guide and/or boat charter must complete an application.

INSTRUCTIONS

Section A. Both fishing guide permit and boat charter applicants must complete this section.

Section C. Boat charter applicants must complete this section.

Section D. Liability Insurance requirement. Insurance must cover ALL periods of time when the owner or owner’s employees are providing fishing guide services to clients. Insurance must be current, not “pending”. Pyramid Lake Paiute Tribe (PLPT) **must** be listed as a Certificate Holder on the insurance certificate.

Section E. Signature is required by all applicants.

Important Notice to Guides and Boat Charters

Pyramid Lake Paiute Tribal Regulations Brochure (Section 21) requires that all licensed guides (including boat charters) providing fishing guide services at Pyramid Lake must apply annually for a permit with the Pyramid Lake Paiute Tribe before guiding activities begin. The fishing guide permit and boat charter application must be completed, signed and dated by the guide applicant and submitted, with fee, and a copy of the insurance certificate, for approval no later than the first Friday of August prior to the season being applied for. **Guides hired by a charter operator must keep the validated permit in their possession while guiding. There is no sub-guides, all guides MUST have a valid Pyramid Lake Fishing Guide Permit. PERMITS ARE NON-TRANSFERRABLE.**

A fishing guide and boat charter should be able to present all documents required for the permit upon request by a representative of the Tribal Ranger Department or any Tribal Police Officer. While engaged in providing fishing guide services, a guide shall have the following readily available for inspection:

- A current Pyramid Lake Paiute Tribe (PLPT) Fishing Guide Permit which has an embossed PLPT stamp
- A valid photo identification card.
